Wash racks will be available the morning of the jackpot. No power available. Plan on keeping your lambs in your trailers as pens will be limited.

**Showmanship classes will be as follows:**

- Juniors: 4-6<sup>th</sup> grade
- Intermediates: 7-8<sup>th</sup> grade
- Seniors: 9-12<sup>th</sup> grade
- Int Advanced
- Sr Advanced - Must show in advance classes if you register for advanced camp.
